

## **Abbreviated Unanimous Declaration of the People of the Candid and Un-candid Natural Republican State of the World for a Call to Global Collaboration**

When in the course of Human events it becomes necessary for a People to separate themselves from the tyrannical rule of the Human Class, they owe it to themselves, their future generations and the Peoples of the Candid and Non-candid World to reveal the unchallengeable facts that leave no other alternative to the separation.

The Facts:

The plan you are about to read is most likely the largest undertaking of its kind in the history of Mankind—even dwarfing its early American experimental attempt in 1774. Now it's time for other nations to have the opportunity to be the leader on the world stage for the quest for Life, Liberty and the Pursuit of Happiness.

It is time for each one of us to decide what motivates us most to do what is right: either our desire to finally reach the heights of freedom and prosperity that we could only dream of in the past, or our strong desire to evade the inevitable slavery and tyranny that faces us if we do not act.

Throughout history, it appears that there has been one major obstacle to Mankind fully achieving the natural right to Life, Liberty and the Pursuit of Happiness. That obstacle has been the sense of one's own powerlessness over political/power-seeking energies that constantly surround us. It is this powerlessness that is responsible for high levels of apathy and aggression.

**However, there is one simple key to breaking free of this obstacle.**

The People must understand that this form of powerlessness can now be removed. The question then arises, “How can the People gain control over a government that claims to implement the People's will, but often seems to do the opposite?”

In the past, even those with the best intentions of doing something about the system of government were doomed before they began because they were too few in number. Any attempt to improve society or the system of government that is supported only by a handful of people, can hardly be true to form as being a Government Of, By, To, For and From the People. This is especially so when their document does not clearly, and without any doubt, identify the People as the Collective Sovereign Authority (Individual Sovereigns assembled as a whole). Anything less is a fraud against the People and a counterfeit proposal. The Natural Flow of Governance occurs when Government flows Of, By, To, For and From the heart of each Family Unit everywhere on Earth—in which the most powerful political platform on Earth is the kitchen table. Together, united by the power emanating from our kitchen tables, we are the Collective Sovereignty. The opportunity now exists to fully implement this Form of Government within any town,

state, or nation desiring it via a modern Information Technological (IT) “missing link”—the United People System.

First, the United People (“UP”) System is open to people from all walks of life and it is not a separate political party. Second, the People now have the opportunity to rise above current powerlessness and to have a profound influence over their society and the system of government under their authority.

Before we can properly address how we can use the UP System, we need to understand who we are and the authority that we must hold over our government. This is the time to address the term “Collective Sovereignty.”

The first of the modern experiments in unleashing the Collective Sovereignty, and the one that inspired all other subsequent experiments in other nations, was the “Unanimous Declaration of These United American Colonies,” (commonly referred to as the Declaration of Independence), which says:

*That to secure these rights, Governments are instituted among Men,  
deriving their just powers from the consent of the governed.*

What this is saying is that in a nation that recognizes the Natural flow of governance, the Government derives its power from the consent of the People. In other words, the People are in charge and Governments and government instrumentalities are organizations created by the People, for the People and they remain subservient to the People.

What is needed is for a majority of People to formally unite which is possible today as never before with the advent of the Internet. The current United People Web site is a sophisticated prototype of the ultimate one that computer programmers around the world will help perfect and continue to improve. It offers the space and the tools that will allow anyone to take part in any decision in any applicable jurisdiction. Community members can now begin experimenting on the prototype United People site to communicate and make decisions amongst themselves and then deliver their collective determinations as “communications” or “directives” to their elected officials.

The process begins with a formal “Call to Unite.” Upon this unification, the People need to make a formal Declaration that they, now united, are the Collective Sovereignty—the very essence of Government itself, and the masters of any level of Government they create. In a subsequent Declaration, the People in each locality, whether it be a town, city, state, or nation, can make it perfectly clear that they—in their full Collective Sovereign Authority—are establishing a Government that is Of, By, To, For and From the People.

It’s time for communities to recognize that they have been harboring a tremendous asset within themselves. This asset is individual Sovereignty.

Individual Sovereigns who wish to assemble as members of the Collective Sovereignty and who feel empowered in exercising their personal responsibility to be active participants in community affairs can now answer a “Call to Action” and take the time

out of their busy schedules to research and study issues that they feel are important to them and their community. These people will be the catalyst for the emergence (or re-emergence) of a sub-element of Government that is truly Of, By, To, For and From the People.

These people can be easily found and identified. In the past, these hard working and caring individuals have been restricted to either calling or writing letters to the editor of a newspaper or their elected officials about issues that are important to them. Some have even demonstrated in the streets, and others join groups or go online to find others who are like-minded. Unfortunately, the efforts of this unorganized community asset have been without any authority and have been, for the most part, rejected or ignored. Up until this time, this valuable asset has not been able to be properly empowered and introduced to the community. It has also been lacking both the technology and the blessing from the overall community for them to act within their capacity as the ultimate proactive check and balance to government.

The United People Project is a continuation of the great ongoing experiment to implement a sub-element of Government that is truly Of, By, To, For and From the People. It is an experiment of the People in order to determine to what degree they can actually commit to directly exercising both their “parental” rights and responsibilities as an overseer of their sub-element of Government. The important thing to understand is that the decision-making base will be open to a considerably larger number of people who represent all social and economic classes—not limited to small and easily-influenced groups that can be manipulated.

This will significantly increase the potential for wise, empowering, and peaceful decisions, and it will also significantly reduce the possibility of errors, damage, corruption, and war. As the world raises its consciousness, the projects initiated on the basis of the United People experiment will shine like lighthouses in the stormy fogs of modern society—calling to it all of Mankind.

Why is a higher level of community participation in Government necessary? The People have allowed their governments to accumulate so much power over them that the thoughts of the People, as commonly observed in the many polls displayed in the media, are completely ignored. The current-day politicians are neither bashful nor afraid of admitting that they are not going to be swayed by opinion polls—even if 80% of the population polled wish to end a war, for example. The People currently have no recourse for two reasons: opinion polls have no lawful authority, and the People have not formally organized themselves in such a way that they could actually achieve that authority and force their elected deputies to comply with their collective will.

In order for the People to motivate themselves into action, they need to take a serious look at their participation in society. After many years of simply exercising one’s responsibility to vote every four years or so, many are witnessing the effects of that minimal degree of the Peoples’ involvement in government affairs. The economy and the rule of law are collapsing; our food supplies, energy sources, and medical services are

getting further from the reach of ordinary People; and there are now perpetual wars with no end in sight. It is now apparent to many that phone calls, letters, or e-mails to elected government officials do not turn the tide around. It has also been found that great and multiple demonstrations by the People do not turn things around. It has also been found that lawsuits against the government by ordinary, honest, good citizens seeking simple redress of grievances fail to be heard and, in turn, fail to turn things around. And lastly, it's now understood that even if there were a complete transition to fully-informed juries that could rule on both the facts as well as the justness of the law, this would represent only the People's ultimate "Reactive" check and balance in government. What the People need now is their ultimate "Proactive" powers. It's clear that the current crisis in government needs immediate attention.

As the People unite and remove themselves from their powerlessness, there's a need to see that the "leadership" element, whether it is among the People themselves or their elected deputies, is thought of on a holistic, global level rather than a limited or self-serving level. However, we should quickly recognize that this does not mean there is a need to break down established national boundaries. When we fully comprehend that we are all the Collective Sovereignty of the World, we have the ability to establish and respectfully recognize various sub-divisions of that Sovereignty. We can maintain our vast diversity even as we strive for unity of mind and purpose—how each of our nations can contribute and unify to form a healthy new whole.

So, there needs to be a great experiment where the People can exercise their options as to how they can become more influential in good decision-making in their sub-elements of Government. The intent is to transform existing wayward government, which only gives lip service to the People's true authority, into a government that listens to and judiciously implements the will of the People, so that the People themselves can self-regulate. The People who come forward to participate in this great experiment will be required to function at a much higher level of consciousness than we have seen from our leaders in the past. The overall community needs to develop understanding and compassion and offer support and encouragement to people amongst their numbers who rise to the occasion to inject that higher level of integrity and responsibility into government, while recognizing that this involvement will be beneficial to everyone. This support will be very important because there might be only a very small number of community members participating at first.

It truly is time to set a new standard of collective cooperation that focuses on a holistic global impact than on a separate or detached local or nationalistic focus. It is also time to establish contracts between the People and their elected deputies that will ensure that the elected deputies will carry out the will of the People when formally developed and presented to them by the People—they will finally become accountable or else they will face extreme legal turmoil, resulting in fines and imprisonment.

This experiment can begin and continue on a local as well as at a global level, and all levels in between. People will educate themselves about their objectives and they can

have significant impact and influence on the sub-elements of Government by giving direct orders rather than issuing a petition or participating in some powerless poll. The sub-elements of Government will be impacted to the degree the People are successful in educating themselves about their authority and assuring that their elected officials carry out their will.

**Let's take a look at a local example:**

There is no doubt that the People wish to have a larger degree of consultation in community affairs than they have had in the past. The challenge is how to do that in an organized and holistic way. In order to accomplish a higher degree of community consultation, we should leave it up to the community to decide the degree of direct community involvement it desires. That is where the UP System comes in. It allows all community members, regardless of their party affiliation or non-party affiliation, to participate in a collective communication and decision-making process. The People determine which issues to address and when they will become involved.

The UP System will introduce itself to the community through a public relations campaign as a means to develop direct community participation and the rationale in order to activate their Collective Sovereign Authority. All community members, collectively (all as Individual Sovereigns and members of the Collective Sovereignty already), have the opportunity to activate their Collective Sovereignty and (through a referendum) will be asked if they wish to do so. A date for a referendum originating from the People will be set. The UP System provides a platform with the adequate instruments for each community to operate this referendum, however each community will be able to use any format or process they desire to conduct the referendum. The date set for the referendum will be sufficient to allow enough time for overall community awareness of the UP System and the education on how to use the system for those who wish to be active participants.

The period of time between the community being first introduced to the UP System and the full activation of its Collective Sovereignty will vary between communities. This is the time when the community can experiment and familiarize themselves with the prototype UP Web site. It is also the time for wise and dutiful elected officials to use the UP System during this experimental period in order to better understand the will of the People in the community.

For the members of a community, the activation of their Collective Sovereignty is of historical significance, comparable to a national day or independence day. Large and popular events called "Collective Sovereignty Day" will take place to celebrate the event. The celebrations will impact on the population as the day they empowered themselves and will significantly raise their awareness of their responsibility as members of the Collective Sovereignty. The memory of the activation of the Collective Sovereignty will be celebrated every year thereafter, to be transmitted to the future generations.

It's absolutely essential to understand that the community members who answer the Call, during any current or future issue within the community after the referendum has been accepted, have the full authority to act in the name of the Collective Sovereignty. Anyone who does not participate in either the referendum or within the Collective Sovereign Authority of the community thereafter, for whatever their reasons, will not be penalized in any way. They will recognize, however, that allowing their fellow community members the opportunity to directly participate in government affairs is a tremendous asset to the community and they will benefit by many of their fellow community members having committed to being the ultimate proactive check and balance in government. The door is always open for all to participate.

Once there is this general understanding, awareness and acceptance, the community initiates a general election. The serious candidate may commit by contract to act in his or her office according to the will of the People as defined by the People's determinations on the UP site.

It must be remembered that once a community formally recognizes its Collective Sovereign Authority, their elected deputies must carry out their will, or the People will have the means to remove them from office.

**Then there are the activities on the global level:**

First of all, it's important to note that the "global" influence of the UP System will grow as the local areas grow and unite with each other. For example, local communities who have activated their Collective Sovereignty will unite until the Collective Sovereignty is activated on an entire state level; and then states that have their Collective Sovereignty fully activated can unite until a unanimous unification of states results in the Collective Sovereignty being activated on a national level; and then entire nations whose Collective Sovereignty has been activated can unite with each other. One nation at a time will voluntarily come under the power of the United People System.

Decisions made within a fully-activated nation will apply only to that nation. If two or more fully-activated nations make a decision jointly, it will only apply to those participating nations. However, just like at the local level, the people of multiple combinations of nations that haven't been fully activated yet can experiment by communicating and making decisions together on the United People Web Site until their areas are fully activated.

It is also important to understand that any decisions made by, and enforceable within, participating nations neither apply to nor are enforceable in other nations whose Collective Sovereignty has not been fully activated and has not participated in the decision.

Suppose there was an issue being discussed at the United Nations and all the member nations are going through a debate. A parallel process could be started on the UP global site, where UP members from anywhere in the world (in both fully activated and non-fully activated areas) could take their place in a discussion within a higher level of

consciousness, going all the way to resolution. The results of this higher-consciousness-level resolution and discussion, including the issues that were raised, could then be made available to the UN, the media, and to interested parties. In this way, the participating UP members would be demonstrating a new way of operating without seeking to compete with the old paradigm.

Another thing the People could do is to conduct experiments on new ways of dealing with “truth.” Someone could develop a situation where a number of different groups with different views of the world could come together and explore their differences. Through this approach, we would seek to understand the dynamics—intellectually, emotionally, and spiritually—that take place when people are confronted with their truth being challenged and maybe even collapsing. Through this work, we would actually learn to understand the dynamics of truth and develop new decision-making processes that allowed for an expansion of the common ground without compromising any particular position.

This would be like a great truth experiment and the results would be tangible and identifiable ways for dealing with truth that transcend the current capacity of Mankind. The UP System would be the perfect vehicle to make such opportunities possible.

**UP Site offers more:**

There is more to the UP Site than the People, in their capacity as the “active Collective Sovereignty,” co-creating policy and delivering it to their respective elected officials, either locally or globally. The UP Site can be used by a community to communicate with each other and to form and implement strategies that they, as a whole community, can use to respond to any perceived threat to the community—an action that may not need to involve the elected government directly.

As a localized example, a group is facing the encroachment of a large supermarket into their small community, which many find as a threat to the economic sustainability of their town. Although the community continues to battle with the supermarket and the local government, which continues to support over-development applications, it would be a good idea for the community to unite on their own in order to form a specific strategy as to how they are going to deal with the super store when it does open its doors. The way the residents react to this issue is completely different and well outside the realm of local government. This would be a perfect opportunity for the residents to use the technology on the UP Site to discuss and develop their community strategy.

**Therefore,** We, the People of the Candid and the Non-Candid Natural Republican States of the World, for the purpose of introducing and implementing the United People System to the World, hereby Declare:

**That there is a UP Marketing Strategy;**

That the commencement of the 2020 Summit in Australia places that country in a UP System-friendly position since it involves the People of Australia in the virtual rebirthing

of their nation; and that its current Prime Minister is also the first to have been sworn into office by clearly pledging his allegiance not to the Queen but to “well and truly serve the Commonwealth of Australia, Her Land and Her People;” and that because of this Australia will hold the top priority in our initial launching process, thereby being its prototype (see ‘Unanimous Declaration of Independence for the Natural Republican States of Australia’ on the Australia level on [www.UPworldgov.org](http://www.UPworldgov.org)); and that other nations that are in a similar position of rebirthing will be considered when they occur and when the UP System has the capacity to include them; and that the People of Australia are currently co-developing their Declaration of Independence on [www.UPworldgov.org](http://www.UPworldgov.org);

That this leads us to the UP marketing campaign itself; and that we need to emphasize the importance of the education campaign that co-exists with the marketing campaign for the UP System; and that this is a process that should be able to demonstrate that the UP System is exactly what the greater community needs in order to expand its direct influence into governmental affairs; and that the only challenge is to obtain acceptance and legitimacy from both the active participants and the community at large;

That until more significant funds are available to bolster our current abilities, efforts are already underway to utilize the best available persuasion techniques, properly tempered with insights found on the history of PR entitled, *The Century of the Self—The Untold History of Controlling the Masses Through the Manipulation of Unconscious Desires*,” by Edward Bernays, who coined the term “Public Relations” (See <http://www.informationliberation.com/?id=8339>);

That as general persuasion techniques refer to products and services, we are thinking about one’s desire to either fully participate in community affairs or fully support other community members who are doing so; and that while not all community members will actually participate in the UP process, it is important that the offer to participate is continually made to all community members; and that it is the time leading up to the referendum that this will be assured;

That a computer program will be created using the best persuasion techniques available, tempered with the knowledge found in the history of PR; and that once a qualitative body of questions are created and placed onto the computer, this will be a great working tool that can be used by UP members to go out and educate others in the community; and that very few UP members will be professional “salespeople,” so the process has to be simple and easily duplicated; and that once face-to-face, the presenter will sit the potential UP member down in front of his or her computer; and that using a carefully designed program on line, the presenter will be able to take the prospect through a series of professionally and purposefully designed questions; and that the objective, of course, is to have a new UP member by the end of the presentation—either an active participant or a supporter of the process; and that because not all community members will actually participate, it’s important that those who do participate receive support from those who don’t, but who understand what the UP System is all about;
